BIOGRAPHY

MAO Hao, Ph.D. in Management, professor, doctoral supervisor of Shanghai International College of Intellectual Property of Tongji University, and director of Intellectual Property Data lab. He was also a recipient of the Max Planck Government Scholarship, senior research fellow, and visiting scholar at Max Planck Institute for Innovation and Competition, Germany. (a member of the team of Professor Dietmar Harhoff, Chairman of the German Innovation Advisory Committee, and the former Chairman of the Advisory Board of the European Patent Office).

Prof. Dr. Mao Hao worked in the China National Intellectual Property Administration (CNIPA) for more than 13 years, and he was selected as the third batch of high-level talents of CNIPA. He served as the liaison officer of CNIPA office in KIPO and the project liaison officer of WIPO Chief Economist Office. During government work, he successively participated in crucial research work such as national intellectual property strategy, national intellectual property planning, construction of world-class intellectual property review institutions, intellectual property administrative system reform, intellectual property service industry, intellectual property intensive industry, intellectual property management of central enterprises, and construction of national intellectual property think tank. As a core member, he has participated in several research designs for federal intellectual property investigations and development evaluations and has accumulated rich experience in policy research and government

work.

In recent years, Prof. Dr. Mao Hao has vigorously tried to use economic research methods to explain the practical issues in the intellectual property legal system and initially established the framework of the economic research system of the Chinese patent legal system oriented to evidence-based decision-making and rooted in the practice of national conditions, and promoted the federal intellectual property interdisciplinary construction and development. In terms of decision-making consultation and research, he was responsible for the "Special Topics on Basic Guarantee of the Intellectual Property Power Strategy Outline" by the Office of the Inter-ministerial Joint Conference on the Implementation of the Intellectual Property Strategy of the State Council, and the major research project of the Academic Committee of the State Intellectual Property Office. He won the National Intellectual Property (Patent) Excellent Research Report and Excellent Soft Scientific Research Achievement Selection First Prize 3 times and Second Prize 5 times. Many of his relevant reports were adopted by the Central Office of the State Council, and state leaders approved 2 of them. In terms of academic research, he presided over two sub-projects of China's National Social Science Foundation 's major projects. He published 24 CSSCI papers (including 13 pieces from National Natural Science Foundation of China A-class journals) and 1 SSCI paper independently or as the first author in the "China Industrial Economy," "China Soft Science," "Intellectual Property," "The Singapore Economic Review" and other economics, management, and law journals.
