- 2. Proof of English proficiency (IELTS 6.5 or TOEFL 95 for non-Chinese citizens and CET-6 for Chinese citizens)
- 3. 2 reference letters
- 4. Curriculum Vitae
- 5. Statement of purpose (max. one page)
- 6. Self-introduction video material for admission (ONLY required for selected applicants. Tongji University will inform these applicants of specific information soon after application period.)
